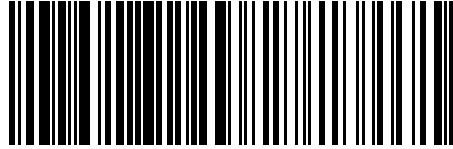





**NOTICE OF VIOLATION OF FEDERAL LAW & DECLARATION OF NULLITY**

To All It Concerns,

This formal notice is hereby issued by Sara Rice McFall© c/o Notary Lisa Kay Ball, 710 East Pine Street, Doniphan, Missouri asserting that all operations conducted within the Ripley County Courthouse located at Doniphan, Missouri, are in direct violation of the 1787 Northwest Ordinance, federal property laws, and constitutional provisions.

This document serves as a demand for the immediate cessation of all judicial and administrative operations due to the failure of the STATE OF MISSOURI and its agents to establish lawful title to the land upon which the Ripley County Courthouse is situated in Doniphan, Missouri. As a result, all court orders, judgments, and legal proceedings, fines, bails, bonds, court costs, taxes, real estate taxes, and real estate assessments from the inception of the Ripley County Courthouse by the 36th Judicial Circuit Court Clerk's office are declared null and void ab initio (from the beginning) back to on or about 1833 A.D.

## **LEGAL BASIS FOR DECLARATION OF NULLITY**

### **1. Northwest Ordinance of 1787 – Requirement of Lawful Land Title**

The Northwest Ordinance of 1787 stipulates that any government authority operating on territory must hold a valid contract of purchase and resultant deed to the property. In accordance with Article I, Section 8, Clause 17 of the U.S. Constitution, the STATE OF MISSOURI is required to produce valid documentation proving ownership of the property on which the Ripley County Court House in Doniphan, Missouri operates.

#### **Relevant Law Cited:**

#### **- Northwest Ordinance of 1787, Article 4:**

"The navigable waters leading into the Mississippi and St. Lawrence, and the carrying places between the same, shall be common highways, and forever free... without any tax, impost, or duty."

### **2. Legal Consequences of Operating Without Lawful Authority**

According to the U.S. Supreme Court ruling in *Ex parte Milligan*, 71 U.S. (4 Wall.) 2 (1866), any court acting outside its lawful jurisdiction is conducting actions *ultra vires* (beyond legal authority). Without proof of lawful title to the land, all orders, judgments, and actions taken by the Ripley County 36th Judicial Circuit are rendered void ab initio effective immediately unless within ten (10) days the STATE OF MISSOURI can produce valid certified and original wet ink signature title to the Ripley County Court House in Doniphan, Missouri.

**Question 1:** Can the STATE OF MISSOURI produce a legally executed deed for the Ripley County courthouse property in Doniphan, Missouri?

- Answer: Absent such proof, all legal actions issued from this location lack jurisdiction and are nullified.

### **3. Violation of Due Process and Equal Protection Rights**

Continuing legal proceedings from a courthouse operating unlawfully constitutes a direct violation of the Fifth and Fourteenth Amendments of the U.S. Constitution. This includes all orders affecting Sara Rice McFall©, and Megan Christian McFall© including, but not limited to Case Numbers 24RI-

CR00308, 24RI-CR00308-1, 21RI-CR00579, 21RI-CR00579-01, 21RI-CR00578, 21RI-CR00578-01 which are deemed unlawful and void due to lack of jurisdiction.

### **DEMAND TO CEASE OPERATIONS IMMEDIATELY**

This notice demands the immediate vacating of the Ripley County Courthouse and the cessation of all judicial and administrative functions therein. Until lawful title to the property is proven, any further legal actions, orders, and/or judgments issued from the Ripley County Court House by the 36th Judicial Circuit Court are declared null and void.

- **Question 2:** How can the State of Missouri justify any legal orders issued from a courthouse operating without proof of valid title?

- Answer: All such actions are invalid, and continuing operations constitute legal and constitutional violations.

### **NOTICE OF LEGAL CONSEQUENCES FOR NON-COMPLIANCE**

Failure to respond within ten (10) business days to this notice with certified documentation and original wet ink documents proving lawful ownership will be considered tacit agreement that no such title exists. Consequently, all court orders and judgments issued by the Ripley County Court House located in Doniphan, Missouri by the 36th Judicial Circuit Court in Doniphan Missouri, including those related to Sara Rice McFall and Megan Chrisitan McFall, are hereby declared void ab initio.

#### **Further Non-Compliance Will Result In:**

1. Filing of formal complaints in Federal Court for constitutional rights violations.
2. Personal liability claims against all officials who continue to act unlawfully.
3. Potential civil and criminal charges for knowingly conducting actions beyond lawful authority.
4. Filing of Constructive Notice Criminal Complaint Affidavit and Brief of Information by Sara Rice McFall© and Megan Christian McFall© is mandated by 18 USC § 4, Denied Full Disclosure, Violation of Due Process, Violation of required Constitutional Oaths, and Violation of my Civil Rights. Points of Law: U.S. Const Article 1 § 10, U.S. Const. Article IV § 1, Amend. 1, 5, 6, 9, 10, and 14, 18 USC §§ 3, 4, 241, 242, 1001, 1621, 1622, 2071, and 2383. 42 USC § 1986 - Rights & Remedies - UCC 1-308, UCC 1-201.

All points not denied and properly rebutted shall be confessed/affirmed, by such default, and shall be accepted as dispositive, conclusive facts by accused/defendants and/or other properly delegated authority, who had the opportunity and "failed to plead." All counter-affidavits must signed with the valid legal name of the respondent and properly notarized. **ARTICLE 6, CONSTITUTION FOR THE UNITED STATES:**

"THIS CONSTITUTION, and the laws of the United States of America which shall be made in pursuance thereof; and all treaties made, or which shall be made, under the authority of the United States of America, SHALL BE THE SUPREME LAW OF THE LAND; and the judges in every state shall be bound thereby, anything in the Constitution or laws of any state to the contrary notwithstanding."...

**16 AM JUR 2D 177, 178:**

The general rule is that an unconstitutional statute, though having the form and name of law, is in reality no law, but is wholly void, and ineffective for any purpose;

Since an unconstitutional law is void, the general principles follow that it imposes no duties, confers no rights, creates no office, bestows no power or authority on anyone, affords no protection, and justifies no acts performed under it;

No one is bound to obey an unconstitutional law, and no courts are bound to enforce it;

An unconstitutional law cannot operate to supersede any existing valid law. Indeed, insofar as a statute runs counter to the Fundamental Law of the Land, it is superseded thereby; the general rule is that an unconstitutional act of the Legislature protects no one. It is said, that all persons are presumed to know the law, meaning that ignorance of the law excuses no one; if any person acts under an unconstitutional statute, he does so at his peril and must take the consequences.

18S/CM Only Congress can coin money (not Federal Reserve, which is an unlawful private corporation)

18SNM Congress has valued Money at 412.5 grains of standard silver (or equivalent gold) to the dollar.

**TITLE 18 SECTION 241 • (18 USC 241) • CONSPIRACY AGAINST THE RIGHTS OF CITIZENS**

If two or more persons conspire to injure, oppress, threaten, or intimidate any citizen in the free exercise or enjoyment of any right or privilege secured to him/her by the Constitution or laws of the United States, or because of his/her having so exercised the same; or if two or more persons go in disguise on the highway or the premises of another, with intent to prevent or hinder his/her free exercise or enjoyment of any right or privilege so secured they shall be fined not more than \$10,000.00 or imprisoned not more than 10 years, or both; and if death results they shall be subject to imprisonment for any term of years or for life.

**TITLE 18 SECTION 242 • (18 USC 242) • DEPRIVATION OF RIGHTS UNDER COLOR OF LAW**

Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any inhabitant of any State, Territory, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishment's, pains, or penalties, on account of such inhabitant being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined not more than \$1,000.00 or imprisoned not more than one year, or both; and if death results shall be subject to imprisonment for any term of years or for life.

THEREFORE, the Court shall punish according to TITLE 18 SECTION 241 / 242.

THEREFORE, the Court shall judge according to 16 AM JUR 2D 177, 178.

311/GB All judges may only hold office during their good behavior (lawful, patient, dignified, courteous, etc.). 612/JB All judges are bound by oath to support the Constitution of the United States of America.

613/BO All law makers, court officials, and enforcement officers are bound by oath to the U.S. Constitution. AM14.3/HO, IR No person shall hold office if he rebels against or violates the U.S. Constitution.

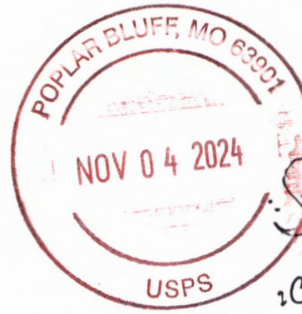
